Interested parties, fulfilling eligibility criteria are requested to submit duly filled quotations in prescribed format on or before 1400 Hrs on 08.02.2023 and quotations will be opened on the same date at 15.00 Hrs. ### Eligibility criteria:-

- 1. Tender document/quotation duly signed and stamped on each page by authorised signatory, as token of acceptance of terms & conditions.
- 2. Profile of Bidder(Annexure-I).( Copy of the all documents should be enclosed)
- 3. The quotes shall be submitted as per Price Bid given in Annexure-II.
- 4. The bidder have to submit the certificate of authorization for disposal of e-waste issued by the appropriate authority.
- 5. The quotations should be submitted in a sealed envelope super scribing as "Quotation for disposal for auction of condemned/obsolete/used electronic/electric e-waste." at Administration Department, IDPL Corporate Office, IDPL Complex, Old Delhi Gurgaon Road, Dundahera, Gurgaon, Haryana-122016 up to 1400 hrs on 08.02.2023.
- 6. The quotations can be submitted in person or through courier/ post to reach within the stipulated date and time. IDPL will not be responsible for any postal delay.
- 7. A quotation, which is received after the specified date and time for receipt of quotations will be treated as "late" quotations and will be ignored.
- 8. Quotations will be opened at 1500 hrs on 08.02.2023.

## Terms & Conditions and General Information.

- 1. The disposal of electronic/electric e-waste shall be on as "As is where is basis" and no guarantee of certificate of its worthiness of quality will be given by the IDPL. The conditions of the items can be inspected physically between 11:00AM to 4:00PM hours on any working days between 25.01.2023 to 07.02.2023.
- 2. All applicable taxes and duties shall be extra which will be paid by the tender/bidder at the time of taking out the materials.
- 3. The sales shall be on "As is where is basis".
- 4. It is responsibilities of the bidder to assess the items properly before quoting the rate. No further claims will be entertained after opening of the bids.
- 5. The amount of the bid shall be valid for a period of 45 days for acceptance from the date of opening of Price bid.
- 6. Bidders cannot withdraw their offer once it is submitted to IDPL, Corporate Office, Gurgaon.
- 7. No enquiry of bidder shall be entertained once the material is lifted by them.
- 8. All labour, tools and equipments for loading/unloading the items from IDPL shall be at the cost of the buyer. However electric power and water shall be provided free of charge at one nearest possible point, if required subject to availability.
- 9. The personnel deployed for disposal action(job) shall strictly obey the safety Rules in force while working in IDPL.
- 10. The job shall be done without damaging/roads/drains/building etc. the buyer shall make good the damages, loss etc. In the event of any occurrence otherwise.
- 11. Taxes, as applicable shall be borne by the H-1 bidder.
- 12. The quotations shall be submitted as per proforma given in Annexures attached to this NIT. Only those bidders who quote all items mentioned in Annexure-II will be considered. Further, highest bidder will be arrived at only on the basis of quoted price of all items collectively.
- 13. The items shall be sold to the highest price of bidder(H-1 bidder).
- 14. The successful bidder will have to pay an advance deposit equal to 90%(in DD) of the bid amount and the balance 10% amount and applicable tax shall have to be paid within 7(seven) days in the form of Demand Draft. The D.D. should be drawn in favor of Indian Drugs & Pharmaceuticals Ltd. payable in Gurgaon or any extended time duly approved by the company. In the event of failure to pay the balance amount within the specified period the amount will be forfeited by the IDPL.
