The contract will be awarded to the contractor / agency based on L-1 quotes and evaluation of by the committee. The decision of the committee will be final and binding IDPL reserves the right to accept or reject a proposal without assigning any reason thereof.

The tender inviting Authority may request the Firm/Agency to extend the bid validity for further period as deemed fit on their original quoted prices and all terms & conditions. However, IDPL reserve the right to place orders at the quoted rate till such period.

All Bids must be accompanied by Tender Document Fee and EMD without which the tender shall be rejected.

IDPL reserves the right to cancel or reject any or all bids at any stage prior to award of contract without assigning any reason.

EMD (Earnest Money Deposit)

The Earnest Money Deposit shall be Rs. 20,000/- (Rs. Twenty Thousand Only) which shall be paid in the form of either, a Bank Guarantee or Demand Draft in favour of Indian Drugs & Pharmaceuticals Limited payable at UBI Rishikesh and the same should be enclosed with EMD advice.

The Earnest Money Deposit will be refunded to the successful applicant within 30 Days from the date of signing the Contract agreement and on the deposit of Security Amount.

The Earnest Money Deposit (EMD) will be forfeited, if the applicant does not execute agreement/undertaking within the period prescribed after the receipt of offer of appointment

Eligibility Criteria:

The contractor should have valid authorization from MoEF&CC /Central Pollution Control Board (CPCB)/ State Pollution Control Board (SPCB) under Rules of the BIO Medical Waste (management & Handling) Rule, for the operation of common facility for the Collection, Reception, Treatment, Storage, Transportation, Treatment and Disposal of Bio- Medical waste.

The contractor should have experience of minimum five years for carrying out the relevant services.

The contractor should have an average turnover of at least Rs. 10 lacs in the last three years.

Scope of Work:

The selected firm (Contractor) shall be responsible for the handling, collection, transport, Treatment and Disposal of Expired Drugs, in the form of Tablets, Capsules, ampoules, bottles API's, excipients, packing materials, and Chemical, available at Virbhadra, Rishikesh-249202 (Uttarakhand). It shall be the legal duty of the firm/agency to ensure that expired drugs are collected, transported and disposed in such a manner that they do not cause any adverse effect on human health or environment, as per the provisions of Bio-Medical Waste (Management & Handling) Rule 2016 (Rules).

All legal responsibility of Expired drugs shall be of the Contractor immediately after it being picked up from the IDPL-Virbhadra, Rishikesh-249202 (Uttarakhand).

If any mishap happens during transportation all responsibility shall be that of the contractor.

Irrespective of shut down/ break down of the plant/ incinerator/ CTF of the Contractor, it will be the responsibility of the contractor to collect Expired drugs from IDPL-Virbhadra, Rishikesh-249202 (Uttarakhand).

In case of breakdown, if disposal is not done within 48 hrs. (as per rules & regulations of Bio- Medical Waste Management & Handling) Rule 1998, all legal responsibility shall be that of the contractor.

The firm shall transport the Expired drugs in a dedicated covered vehicle to an authorized waste treatment facility center as per Rules and time to time according to instructions issued from the MoEF&CC / CPCB /SPCB.

It would be the inescapable duty of the firm to ensure that the instrument and practices used for the treatment and disposal of the waste is duly complied with the standards prescribed in Bio- Medical Waste (Management & Handling) Rules.

The firm will provide Photograph and video clipping (In CD/ Pen drive) as a proof of the entire disposal process of the expired drugs collected from IDPL-Virbhadra, Rishikesh-249202 (Uttarakhand).

The entire process of collection, transportation & disposal of drugs will be executed in presence of IDPL officials.

The firm (Contractor) would be required to assist IDPL in filling annual reports and other reports/ records as mandated by the appropriate pollution control authorities from time to time. The contact shall not be transferable to any one and the contractor shall be personally liable in respect of this arrangement.

The management of Indian Drugs & Pharmaceuticals Limited (IDPL) shall have the right to withhold payment, terminate the contract or make the recovery from the agency in respect of any losses or damage caused or occasioned due to violation of statutory obligations or unsatisfactory performance.

Performance Security:

The successful bidder shall have to submit performance security of Rs. 20,000/- in the form of Demand Draft drawn on any scheduled bank in India or Bank guarantee issued by any scheduled bank in India during the currency period to safeguard the interest of the company to ensure that the firm completes the work as per norms ordered by IDPL.

The bank guarantee shall be unconditional and shall be valid till minimum six months beyond the scheduled date of completion of work. In the event of any failure / default of the contractor, with or without quantifiable loss to the company the amount of the performance security is liable to be forfeited.

Performance Security shall be returned to the party after successful completion of the work and shall bear no interest.

Arbitration Clause:

It has been mutually agreed between the parties that all differences and disputes arising during the contract period regarding interpretation of the contract shall be solved by mutual discussion. In the event of difference or dispute remaining unsolved, the same shall be referred for arbitration to the General Manager or his representative of Indian Drugs & Pharmaceuticals Limited (IDPL) and his decision shall be final and binding on all parties.

This contract shall be deemed to have been concluded at Rishikesh for all purposes and therefore only courts of Dehradun shall be having jurisdiction for the purpose of any adjudication where some dispute/obligation remain unsolved despite arbitration.

Payment Terms:-

Payment will be on assignment basis within one month from the date of submission of invoice by the contractor / agency after completion of work done during the calendar month duly certified by the certifying officer/authorized person of the Indian Drugs & Pharmaceuticals Limited (IDPL), Virbhadra, Rishikesh-249202 (Uttarakhand). No advance payment will be made.

Force Majeure:

If at any time during the currency of the contract, either party is subject to force majeure, which can be termed as civil disturbance, riots, strikes, tempest, acts of God etc. which may prevent either party to discharge his obligation, the affected party shall promptly notify the other party about the happening of such an event. Neither party shall by reason of such event be entitled to terminate the contract in respect of such performance of their obligations. The obligations under the contract shall be resumed as soon as practicable after the event has come to an end or ceased to exist. If the performance of any obligation under the contract is prevented or delayed by reason of the event beyond a period mutually agreed to if any or seven days, whichever is more, either party may at its option terminate the contract.

All type of Capsules / Tablets / Syrups / Injections / Sachets, Bottles, Chemicals, Packing Materials & Disposable Items, API's, and Excipients etc.
