The items awarded to your firm will be supplied against valid Drug Licence numbers i.e. 222 and 90 respectively. The rates approved are subject to the following:-

- 1. Delivery within 6 weeks (from the actual date of dispatch of supply order) on F.O.R. destination basis.
- 2. Rates are inclusive of excise duty.
- 3. CST/ST/VAT as applicable will be extra except for items where 'No Tax' has been approved.
- 4. If at any time documents submitted/information given by you in tender is found to be false/erroneous, the award will be cancelled.
- 5. Supply of drugs is to be made directly.

The Rate Contract will come into force with effect from <u>26.02.2015</u> and the supplies will have to be made available from this date. Order/orders would be placed by the Direct Demanding Office against this Rate Contract upto **25.02.2017**.

1. A list of Chief Direct Demanding Officers of the various States who are authorized to operate this Rate Contract is enclosed. The Chief Direct Demanding Officer will send you the list of Direct Demanding Officers of their States authorized to operate this rate contract. Supplies will be accepted and payment will be made by the Direct Demanding Officers

- 2. As the Rate contract holders, you shall ensure, while making supplies, that all labels on Tab./Caps/Bottles/all type of packs including the cartons/boxes etc. are imprinted/stamped with 'ESI SUPPLY NOT TO BE SOLD' in bold letter with red indelible ink failing which supply can be rejected by the Direct Demanding Officers. Such marked medicines shall not be sold to any person who is not in the list of Direct Demanding Officers. Such marked medicines shall not be sold to any person who is not in the list of Direct Demanding Officers.
- 3. Whenever the sale is made to Govt. Department or such consignee who is entitled to avail of benefits of concessions in rate of Sales Tax under the Central Sales Tax Act, or the State Sales Tax Act and the rules framed thereunder, the Rate Contract holder shall obtain Form 'D'/relevant Certificates or declaration in time and shall levy the Sales Tax as applicable on confessional rates only.
- 4. A quarterly statement regarding supply/orders received and the supply/supplies made shall be sent to this office by Rate Contract holders so as to reach within 10 days of the close of the quarter. If there are no order/supplies a 'NIL' report shall be sent. The report should have details of the Rate Contract No., Item No. and Name of Drugs, Direct Demanding Officer's, Supply Order No. and Date, Quantity ordered, Quantity supplied and date of supply. Quantity not supplied, reason for non-supply etc.
- 5. Normally no rates revision will be allowed during the currency of this Rate Contract but the statutory revision may be considered on merit on request from the Rate Contract holders if made within 30 days from the date of notification of such revision, alongwith the copy of the Gazette Notification/DPO. But if there is a downward revision in the rate, it shall be obligatory on the part of the firms to pass on the information with documents for revision necessarily within 30 days otherwise action may be taken against the firms.
- 6. If at any time it is found that the documents submitted are forged or the information given in the tender is found to be wrong, the award of the Rate Contract will be cancelled immediately and further action will be taken as per the terms & conditions of the Rate Contract.
- 7. Details of the conditions given in the contract with other firms are hereby reserved.
- 8. This is only an intimation letter and is not to be used for obtaining supply orders.
